Beschreibung

This seminar combines approaches from urban and architectural history and theory in order to investigate the complexity of the built environment in the long 20th century. Starting in the late colonial period, moving on to the ruptures of decolonisation and changing spatial orders of the Cold War, the seminar will also examine how the legacies of these governance regimes continue to shape cities today. Aiming to challenge the entrenched positionalities of Eurocentric research traditions, the regional focus is shifted to the so-called "Global South" (as contrasted with "Global North"). Over the course of three full-day meetings, several themes and topics shall be discussed with reference to different temporal frameworks and geographical scales, such as:

- development and implementation of colonial urban policies/ processes of spatial segregation/decolonisation;
- circulation of planning knowledge and practices;
- globalisation of construction industries;
- discourses on tropical architecture;
- conflicts related to urban/architectural heritage.

Thus, by investigating flows of ideas and know-how, labour or capital, the material history of globalisation shall be traced by the students. The main goal of the course is to develop a critical reflection on the processes shaping the built environment and to analyse them from different viewpoints (e.g. material culture studies, postcolonial theories).

In the first meeting students will choose the topics of their assignment (presentations of max. 20 minutes) which will be delivered and discussed in the meetings in January. Own suggestions for topics are encouraged.

Because the number of participants is limited to 10 for this physical block seminar, if you are interested, please submit a short letter of motivation (max. 300 words in English or German) to monika.motylinska@leibniz-irs.de until 28 October 2020, 12pm (noon), indicating your matriculation number. Should the pandemic situation worsen, the seminar will take place online on given dates.

Die Suche nach Ansätzen einer nachhaltigen und zukunftsfähige Entwicklung und Gestaltung von Stadträumen im Kontext der aktuellen Herausforderungen gesellschaftlicher, klimatischer, infrastruktureller sowie digitaler Wandlungsprozesse, erfordert den Umgang mit komplexen Problemstellungen, Konflikten, Unvorhersagbarkeit dynamischer Prozesse und das Denken innerhalb langfristiger Zeithorizonte. Wie gehen Städtebauer*innen in Praxis, Lehre und Forschung mit diesen Herausforderungen um? Welche Positionen entwickeln und vertreten sie, um sich innerhalb eines solchen komplexen Aufgaben- und Gestaltungsfeldes zu verorten und handlungsfähig zu bleiben. In der Veranstaltung setzen Sie sich mit Hilfe von Fachvorträgen und Lehrbeispielen mit den Positionen verschiedener Städtebauer*innen auseinander und entwickeln eine kritische Reflektionsebene zu verschiedenen Herangehensweisen im städtebaulichen Entwerfen und in der Vermittlung des städtebaulichen Entwurfes.

"Critical Ecology" Matters: An Interactive Card-kit Introducing Tomás Maldonado's Work

What if the answer to the current environmental crisis is to move beyond a hopeless nostalgia for the environment, in favor of developing ecological thought processes?

What if we don't need a macro revolution that ends up ultimately cynical in the streets, but one that embraces the micro revolutionary potential in daily design decisions?

Is it possible to move beyond the more systematic modes of dealing with the environmental question to ones that support designers to make sense of the systemic complexity of design problems?

The questions mentioned above were at the crux of Tomas Maldonado's work between 1956 and 1972. They are central to the definition of a concept of "critical ecology" in his Book Design, Nature, and Revolution (1972).

Due to his fading popularity within Ulm and his struggle with formulating these ideas precisely, his work during this period has gained very little attention.

Convinced that the modern university is not suited for the task of developing the necessary modes of imagining the complexity of assembled human-nature relations, he called for a different form of teaching about environmental complexity ("Bauhaus after Bauhaus").

In the face of the multiple crises today, Maldonado's discourse on critical ecology provides a valuable framework for understanding design imagination as part of a technological imagination that does not lose touch with the sociological imagination. This project aims at a historical reconstruction of the notion of "critical ecology," as it appears within Maldonado's work between 1956 and 1972. As such, throughout the seminar, we will trace his work in particular archives and organize the ideas as a playful interactive card catalog. By re-organizing the knowledge playfully (operating beyond language differences), the interactive card kit will attempt to fill the gap between historical research and the forms of information more helpful in operational design research that aid designers to think through a design problem.
